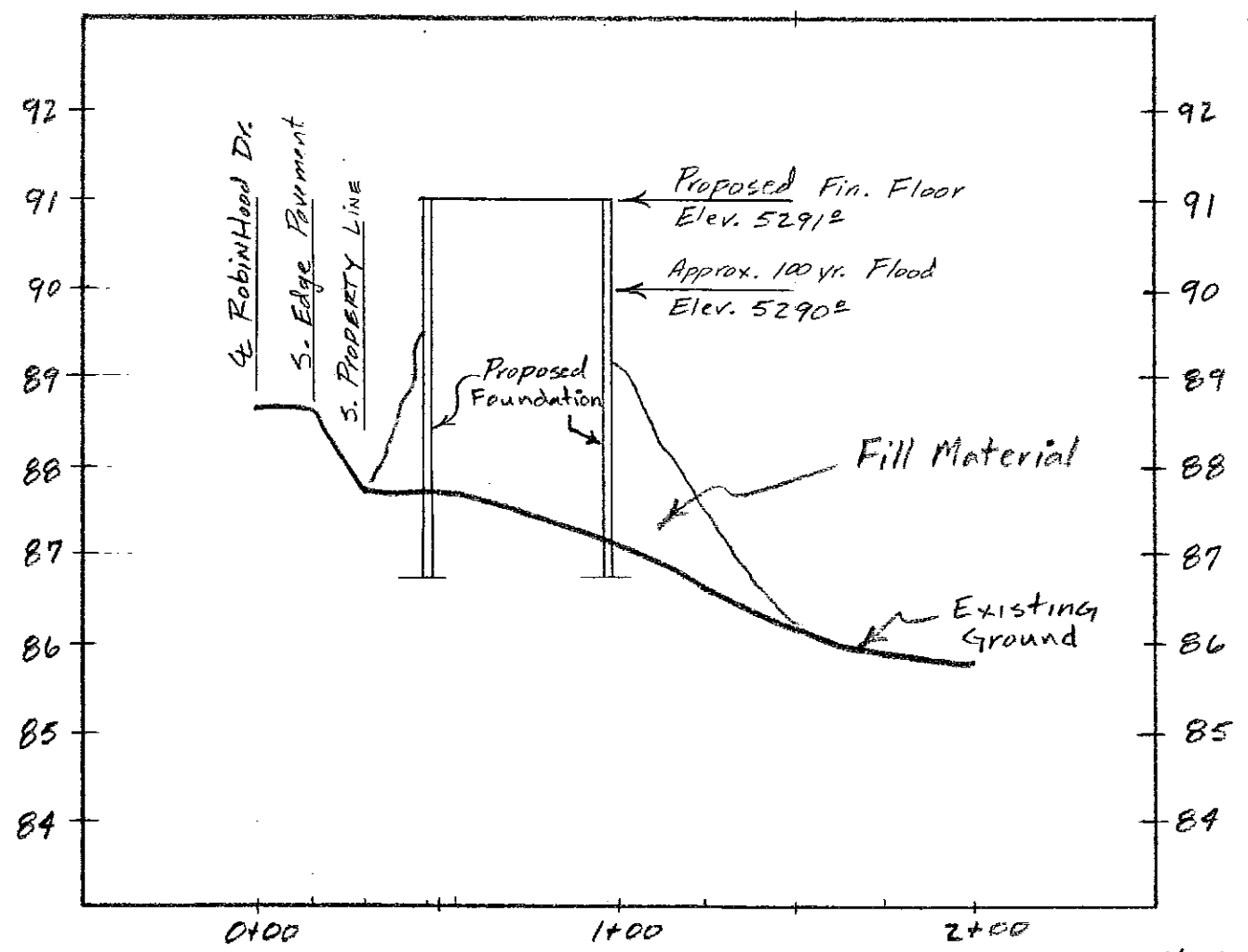

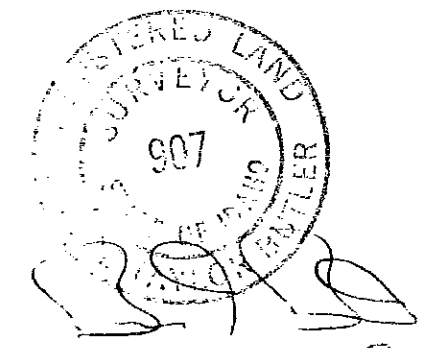


PLAN VIEW
