 The Benchmark used was converted from NGVD 1929 to NAVD 1988 using the FEMA FIS Report Datum conversion (3.7 Feet), since the property lies between cross sections BD & BE.

The Lowest elevation of machinery or equipment servicing the building listed in C2(e) is Heat Ducting. The Bottom of an Electrical Plug is at an Elevation of 5287.2 Feet.

This is a revised certificate to correct an error in calculating net area of flood vents as Smart Vent Model 1540-520 will cover 200 sq. ft. per vent. C2A is also 0.1 higher now.
