Proposed Budget for Fiscal Year 2017

A public hearing , pursuant to Idaho Code 50-1002, will be held for consideration of the proposed budget for the fiscal year October 1, 2016, to September 30, 2017. The hearing will be held at the Hailey City Council Chambers, located at 115 Main St. S, Hailey, Idaho on Thursday, August 25, 2016 at 9:00 am. The Agency budget funds the programs, services, and capital projects that the Agency Board and City Council, by way of adoption of potential urban renewal plans, may determine to be important to meet the Agency's strategic goals and meet the needs of the residents and businesses within the Agency's boundaries.

City Council Resolution No. 2010-02 adopted on January 25, 2010, authorized the establishment of the Urban Renewal Agency. The Agency has now completed the urban renewal plan for the Gateway District, thereby establishing the baseline of assessed value according to 2014 values. The Agency expenses will primarily include capital projects, insurance, legal expenses and other consulting expenses in FY 2017. Those activities will be funded through the projected tax increment revenue of \$100,000, which is based on the baseline property tax value of 2014. The budget below shows the breakdown of anticipated expenses for FY 2017. For FY 2017, the Agency's revenues will be limited to tax increment revenues and interest.
